- 11. That the school shall met run unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nurdery classes be removed from the premises of the school immediately.
- 12. That the school shall dispense with the services of unqua--lined and over-accomstaff, if any, immediately.
- 13. There the service contract between the management and the envicyee chall be executed immediately.
- 14. Then all the facilities prescribed under Rule 50 and 51 of the Delhi Sch of Education Rules, 1973 shall be made available to the attribute.
