10. That the management will not utilise any portion of the school premises for any purpose other than educational activities.

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing Middle school to Secondary school level without aid w.e.f. 1986-87 session subject to the fulfilment of the following terms and conditions:-

- (1) That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
- (2) That the school shall admit students without any discrimination of caste and creed.
- (3) That the school will meet the additional liability of Secondary classes.
- (4) That the school shall equip the Science Lab. as per norms of the Department and suitable facilities for practical work shall be provided to the students. Science material worth Rs.10,000/- may be purchased within a period of one year.
- (5) That a proper library shall be established and facilities for reading room shall also be made available for students as well as to the teachers. Books as per the ratio of 10 books per student worth Rs.5000/- shall be purchased.
- (6) That adequate sports material shall be purchased and made available to the students.
- (7) That the school shall strictly abide by the provisions of Sec.10(i) of the Delhi School Education Act & Rules, 1973.



- (8) That the enrolment of each section shall not exceed the number of students calculated @ 12 Sq.ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Dto. of Education in each class. Number of sections should not exceed the number of existing class-rooms of proper size in the school.
- (9) That the school shall not run any unrecognised classes, or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
- (10) That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
- (11) That the service contract between the management and the employees shall be executed immediately.
- (12) That all the facilities prescribed under rule 50 and 51 of the OSER, 1973 shall be made available to the students.
- (13) That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
- (14) That the management of the school shall create a Reserve fund of Rs. 10,000/- (Rupees Ten thousand only).
- (15) That the violation of any instructions/orders/conditions/rules and regulations of the Deptt. shall lead to the withdrawal of recognition of the school.
- (16) That the Nursery classes will not run in the building occupied by the school.






6. That more sports material worth Rs. 500/- or out-door games shall be purchased and made available to the students immediately during 1988-89.
7. That the school shall strictly abide by the provisions of section 10(i) of the Delhi School Education Act & Rules, 1973 and payment shall be made through crossed cheque. Service Agreement shall be executed with all the members of the staff and recommendation of the IVth Pay Commission shall be implemented strictly and a war if any be given immediately.
8. That the scheme of management of the school may be approved from the department immediately if approved, list of the members be submitted to DDE (Act).
9. That the enrolment of each section shall not exceed the number of students calculated @ 12sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school and each class-room, science labs. and library rooms may be fitted with proper electrical appliances.
10. That the enrolment in each class shall be increased sufficiently particularly in X and XI for the benefit of the student.
11. That the school shall not run unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately.
12. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
13. That the service contract between the management and the employee shall be executed immediately.
14. That all the facilities prescribed under Rule 50 and 51 of the Delhi School Education Rules, 1973 shall be made available to the students.

17. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
18. That the school building shall be constructed within a period of three years.
